






## WHAT ADDITIONAL FACILITIES DO WE NEED TO BE PROVIDED TO SUPPORT VISITORS TO THE AREA?



## Feedback from reading the Discussion Paper and further comments

#### Other issues raised

#### Infrastructure

Upgrade the pool; bring back makers Workshop; better shared pathways; city gateway; upgrade Yacht Club; develop the waterfront; tourism information centre; no more sports centres; coastal pathway east of Burnie;

#### Retail

more large retail; encourage night markets and night shopping; reduce rents

#### Tourism

The volunteers are amazing for cruise ship; loads of natural attractions i.e. penguins, Fern Glade, beachfront; camping ground and caravan park; mountain bike tracks; canoeing course; extreme sports facilities; develop better website for tourism;

#### Sustainability

Housing designs to reduce concrete and lighter colours (avoid heat banking), increase tree cover; employe sustainability officer;

#### **Strategic Sites**

Council divest surplus lots with specific development opportunities to contribute to the overall aim of this strategy, some of which may need to be rezoned as a priority; a number of strategic sites have been identified and alternate uses provided

#### Other issues raised

#### Services

improved public transport (including late night); support sporting/community groups; loads of natural attractions i.e. penguins, Fern Glade, beachfront; bypass Burnie; more childcare centres; provide shuttle bus for families to attend sports; strategise and review existing assets and supply new social infrastructure in strategic locations in conjunction with existing and future settlement

#### CBD

Rates are too high, need more support for business setting up; safety, remove homeless people; meld green spaces with CBD; more supermarkets; return the town clock; identify land that could be better utilised or strategically positioned to benefit community; support clear planning controls for CBD (i.e. Specific Area Plan); limit height of developments; encourage joint private/public development within CBD; alternate entry point into the CBD;

#### Housing

Council progress opportunities to meet housing needs for renewal energy projects; more diverse stock needed; higher density needed both in and around CBD; review ratio calculations for dwelling yield;

## Feedback from reading the Discussion Paper and further comments

#### Other issues raised

#### Land Supply

Proposed supply should be further tested for developability test, i.e. servicing;

#### Council

Needs to listen to the community; a Council that works together and behaves as a team; local government amalgamation; needs to support families and local businesses; better communication between Council and community; utilise local organisations / groups to help implement your plans; Burnie needs to keep a majority share in the airport; Council to be transparent with decision making; reinvest in the community; needs a vision and a social plan; remove General Manager and all senior management and Councillors; leverage existing Council properties;

#### General

Statistics are based on old data and projections flawed; need things to do; greater police presence; Burnie needs an identity; change the name of Burnie; support arts and cultural events, Arts Advisory Committee; need to make building houses easier; stop parking meters; more services to rural areas; retain assets (do not sell them off); 24 hour dog control; invest in full STEM educational options with UTAS;

### Food and Feedback Session

#### Housing

Not enough variety; need units for people wanting to age in place; buildings could be repurposed for studio apartments; there should be options for student accommodation; challenging to buy a house now; housing commission properties should not be grouped together; vacant land at Cooee could be used for tiny homes for short term solutions for people and surge accommodation for workers; need for over 55 age bracket lifestyle communities; need good housing to assist in attracting works to the area; need for more quality land and quality housing; need to avoid housing expanding into agricultural land

#### CBD

The central area is missing activation; businesses are shutting; cruise ships are back but nothing to keep them in the CBD; the beach at the end of CBD is an asset; the city needs renewal; not enough to do that does not cost money; needs live music scene; blank walls in CBD and arcades do not feel safe;

### Food and Feedback Session

#### **Shopping and services**

Shopping is limited; need bigger department stores; no late night shopping; no events; no cultural festivals; people go to Ulverstone, Devonport or Launceston for shopping; indoor play facilities; toddler pool; combine community facilities

#### Transport

Lack of public transport; need an eco friendly rail trip to Strahan; roads not designed for heavy vehicles; loss of railway line impacts opportunities for big business; lack of e-scooters

#### **Urban Design**

Need shade in the city; more accessible; foreshore is under utilised; lighting needs to be improved; better footpath connection; open spaces in the CBD; trees; murals by local artists; basketball courts; outdoor climbing area; South Burnie needs investment and beautification

### Food and Feedback Session

#### **Community Culture**

Can be classist with large demographic heavily relying on social services; socio economic issues; homelessness; aspirations for the young are changing now; more opportunities; Australia Day services; need to change the narrative good things come out of Burnie

#### General

A good place to live; good for families; great quality of life for kids; needs of the community changing as it ages; need to have good access to sport and other activities; Burnie feels like the forgotten about city; feels unsafe; kids are bored and get into trouble; Council needs to communicate in a way that is inclusive of our aging population; penguin viewing area should be upgraded; showgrounds be reused

#### Health

High turn over of staff at hospital; lack of specialist services; need more GP's; need more mental health services; parking at hospital is problematic particularly for aging community
